Commencement of work relating to the contract prior to the end of the cancellation period Regulation 9-(1)

Where the consumer enters into a specified contract and he/she wishes the performance of the contract to begin before the end of the cancellation period, he/she must request this in writing.

(2) Where the consumer cancels a specified contract in accordance with regulation 8 he/she shall be under a duty to pay in accordance with the requirements of the cancelled contract for the goods and services that were supplied before cancellation.

This element of the regulations is likely to apply in all instances that a funeral director will be involved with. Therefore, to ensure-should cancellation of a contract occur-that you have the ability to charge for services provided, the client's authority to commence work should be obtained.

Authority to commence performance of the contract within the cancellation period

If you wish the performance of this contract to commence within the cancellation period, you should sign this authority to enable work to commence in agreement with the contract to provide the goods and services associated with the contract.
